- Your unique ID number is generated.
- Now you are eligible to purchase products on discounted price (D.P.)  
IF PRODUCT MRP = 1000.00  
30 % DISCOUNT = -300.00  
700.00 (DP PRICE)
- Now you have to purchase INR 1000 product on DP to activate your ID and company gives you sponsoring right to grow your team and business.
